Congressional Update

After a contentious week that saw 14 elections end without a speaker, Kevin McCarthy (CA-20) was finally chosen to lead the 118th Congress. Among major concessions granted by McCarthy to his detractors was a "motion to vacate" that allows any single member to call for a vote to remove the speaker from office.

The House will now begin to conduct legislative business. There was a vote on several House rule changes, some of which have been implemented by previous R-controlled chambers, and some that are new to the Hill. Some of the proposed changes include: budget caps on future negotiations (based on FY22 levels), cuts to defense spending, a 3/5s majority needed for tax increases, votes on all spending bills, "cut go" spending whereby new spending needs to be paid for with cuts rather than new revenues, the establishment of a "Tough on China Select-Committee", a full accounting of earmarks from the FY23 omnibus bill, the "Holman Rule" which allows Congress to amend spending bills with the intent of salary reduction or employee termination at federal agencies, and 72 hours for Members to read bills. The rules package further requires committees to weigh whether any programs should be moved from mandatory funding to discretionary funding, which would force that spending out of an automatic process every year and into one controlled by lawmakers.

Congressional Outreach

Connect Transit CEO, David Braun, along with other transit leaders in the 17th Congressional district of Illinois and Laura Calderon, the Executive Director of Illinois Public Transit Association met virtually with newly-elected Rep. Eric Sorensen and his district director, Shawn Borich Hernandez on Jan 17th. During the meeting, David and the other agencies explained how they are funded through federal grants for capital projects, who their ridership is, described their service areas, and filled the Congressman in on what trends and challenges in public transit that he will be hearing about throughout his term. Sen. Durbin and Rep. Sorensen visited the Connect facility on Jan. 18th to celebrate the \$2.78 million earmark from FY22 that Sen. Durbin secured for Connect to purchase electric buses. Unfortunately, there will not be any earmarks from FY23 that will be directed to Connect from any members of their delegation. Cardinal is continuing to monitor the FY24 appropriations process and will be in touch with Connect leadership, as well as other local governments and stakeholders, to put forth applications for additional project funding.

STB Vice Chair Announced

The Surface Transportation Board (STB) <u>has selected</u> current Board Member and Democrat Karen J. Hedlund as the new Vice Chairman of the board. Hedlund, who is a current board member, will replace Republican Michelle Schultz. The STB's Vice Chairmanship rotates among the Members on an annual basis.

Five Transit Topics to watch in 2023

Mass Transit Magazine recently published <u>five transit topics to watch in 2023.</u> They include; pursuing lower emissions goals, continued inflationary and supply chain pressure, the frustration and innovation of modern recruiting, bridging the gap between perception and reality in rider experience, and the continued growth of microtransit.

ARPA Funding

Tucked into the recent Consolidated Appropriations Act of 2023 was a change in how Federal coronavirus relief dollars could be spent on things not directly related to the pandemic. Under the rules, state and local governments will be able to use up to \$10 million or 30% of their American Rescue Plan allotment, whichever is greater, for transportation infrastructure projects like new roads and bridges as well as aid to people affected by natural disasters. The newly expanded spending options are expected to take effect by late February, after the Treasury releases updated guidance.

House Transportation & Infrastructure

Rep. Sam Graves (R-MO) has been selected to serve as Chairman of the Transportation and Infrastructure Committee (T&I Committee) in the 118th Congress, the Republican Conference reported Jan. 10. Graves has served as the Committee's Ranking Republican Member for the last four years. Among the many items on his agenda for the upcoming two years are executive administration oversight, implementation of the Infrastructure law, a pipeline safety bill, a Coast Guard bill, the next Water Resources Development Act, and more. Rep. Rick Larsen (D-WA) will be the Ranking Member on the democratic side of the Committee. Full membership rosters are still TBD.

EPA Heavy Duty Trucks

The Environmental Protection Agency recently <u>finalized</u> stricter clear-air standards for heavy trucks that the agency said are 80% stronger than current limits. The new rules, which will go into effect starting in 2027, is estimated to reduce nitrogen-oxide emissions from trucks by more than 40% by 2040 and by nearly 50% by 2045.

2023 RAISE NOFO

The Department of Transportation recently published an amended RAISE NOFO available <u>here</u>. The deadline for applications is 11:59 PM EST on February 28, 2023 and selections will be announced no later than June 28, 2023.

Areas of Persistent Poverty NOFO

The FTA <u>announced</u> recently that \$20 million in competitive grant funding is now available for FY 2023 through its Areas of Persistent Poverty (AoPP) Program. The AoPP program supports planning and technical studies to improve public transportation in areas experiencing long-term economic hardship. Applications are due by 11:59 PM EST on Mar 10, 2023.

LowNo and Bus and Bus Facilities

Here is a list of DOT's upcoming grant opportunities for 2023, the estimated release date for the associated NOFO, and the administering agency. Now that DOT has had a year under their belt to implement these programs, they should be timelier. However, these are seasonal rather than specific ranges and are subject to change. The LowNo and Bus and Bus Facilities NOFOs are expected in late-January or early-February.

Summary

This month, our team met with multiple stakeholders, including the Illinois Association of School Boards, to discuss the Statement of Economic Interest form disclosures concerns. This follows extensive work from our team since this issue was brought to our attention, including conversations with the House sponsor, Illinois Municipal League, Illinois State Association of Counties, Township Officials of Illinois, and other stakeholders; outreach to Connect's state representatives and senators regarding concerns with the requirements and potential changes prior to the end of the 2022 session; and drafting a letter of concerns to send. Unfortunately, we have now been informed by both the House and Senate sponsors of the original legislation that the current language meets their intended purpose, and they have no interest in opening up the language at this time.

Additionally, we spoke with House Democratic regarding Rep. Chung's attendance at Connect's recent media event. Our team also committed to sponsoring Connect's 50th Anniversary Birthday Party, and we are working to get the appropriate contact information to invite Sen. Tom Bennett to the event. As session continues, we will continue to keep Connect updated with legislation that could impact Connect's goals.

Short Description: AGING EQUITY ACT

Synopsis As Introduced

Creates the Illinois Strategic Action Plan for Aging Equity Act. Provides that the purpose of the Act is to appoint a planning commission to research and develop a comprehensive, crosssector, long-term strategic action plan for aging equity that will lead to actionable goals and measurable outcomes for the years 2024 through 2036. Establishes the Strategic Action Planning Commission for Aging Equity. Provides that the planning commission shall be made up of State agency directors and appointed elected officials or their designees as ex officio members, and a group of voting individuals from the general public. Provides that the planning commission shall examine the effects, challenges, opportunities, and needs for planning related to the shifting age demographics toward an increasing portion of the State's and localities' populations being made up of older adults. Requires the planning commission to adopt guiding principles that include, but are not limited to: (i) advancing aging equity across the life course; (ii) developing cultural humility and being culturally responsive with inclusive policies, programs, and services; and (iii) harnessing the power of experience and knowledge of older persons in communities. Requires the Governor to appoint members to the planning commission within 3 months after the effective date of the amendatory Act; and to consult with the President and Minority Leader of the Senate, the Speaker and Minority Leader of the House of Representatives, and the Director of Aging about member appointments to ensure that (1) the planning commission reflects the geographic diversity of the State; (2) the planning commission is inclusive and consists of members who reflect a diversity of age, gender, ability, race, cultural, socioeconomic, and national background; (3) the planning commission includes Illinois residents age 60 or older; and other matters. Contains provisions on the composition of the planning commission; commission meetings; the commission's authority to establish a subcommittee; the establishment of an advisory committee; duties of the planning commission; data analysis; planning commission recommendations and reporting requirements; and other matters. Effective immediately.

House Sponsors Rep. John M. Cabello

Synopsis As Introduced

Creates the Prohibition of Closed-Door Tax Increases Act. Provides that a unit of local government may not increase a levied tax without authorization by referendum of the electors of the unit of local government. Provides that a referendum to increase a levied tax must include a sunset clause on which the tax increase authorized by the referendum measure shall expire. Provides that, if an increase in a levied tax is intended to generate a cash flow to service a debt, the increase must sunset no later than the date that the debt is scheduled to be paid off, and, if an increase in a levied tax is intended to generate a cash flow that will be spent for purposes other than debt service, the increase must sunset no later than 10 years after the date on which the tax increase begins. Provides that, to the extent this Act conflicts with any other provision of law, this Act controls. Provides that nothing in the Act infringes upon the right of a unit of local government to impose or increase non-tax fines or fees. Provides that the Department of Revenue shall adopt rules to enforce the Act. Limits concurrent exercise of home rule taxing powers.

GOVERNOR'S HIGHLIGHTS:

Governor Pritzker traveled to Davos, Switzerland this week to speak at the World Economic Forum Annual Meeting. Governor Pritzker highlighted the Climate and Equitable Jobs Act, the Reimagining Electric Vehicles Act – and Illinois' commitments to clean energy and sustainable power – the Rebuild Illinois Capital plan, and Illinois' new laws on reproductive health and gun violence prevention.

Before returning home next week, the Governor will also visit Germany for business development purposes.

New Laws: Two bills passed during the lame duck session were signed into law this week. Governor JB Pritzker signed omnibus reproductive rights and gender affirming legislation – <u>HB 4664</u>. Read more <u>here.</u> Also signed this week was <u>HB 240</u>, which is an omnibus healthcare package.

Education Budget Requests: The Illinois State Board of Education and the Board of Higher Education submitted their Fiscal Year 2024 budget requests to the Governor for consideration as the Governor's Office of Management and Budget finalizes the Governor's Fiscal Year 2024 budget. The Illinois State Board of Education is proposing a \$350 million increase for the Evidence-Based Funding for K-12 and a 10% increase for pre-K and early learning. Advocates argue that more funding is needed to fully fund the Evidence Based Funding Formula fully within 10 years and to fully fund early education.

Meanwhile, the Illinois Board of Higher Education is requesting a 7.5% increase in the total direct funding for the state's public universities and community colleges. The total proposed budget is around \$2.5 billion, an increase of \$180 million from the FY 23. The FY 24 budget request also includes a \$50 million increase in MAP funding. More information is here.

The Governor will present his proposed FY 24 budget to the Illinois General Assembly on February 15.

Nursing Grants: Across the state, the Illinois Board of Higher Education awarded 11 nursing school grants, totaling \$750,000, and 40 nurse educator fellowships, totaling \$400,000, for fiscal year 2023. The grants were awarded to institutions of higher education to help increase the number of registered professional nurses with high-quality postsecondary credentials to meet the demands of the Illinois economy. The fellowships are designed to help retain well-qualified nursing faculty at institutions of higher education that award degrees that lead to a registered nurse licensure. Read more here.

Solid Waste Management Plan Grants: A new funding opportunity is available to assist counties and other units of local government in implementing their solid waste planning obligations under the Illinois Solid Waste Planning and Recycling Act (SWPRA). The Notice of Funding Opportunity (NOFO) is here.

Under the SWPRA, counties and units of local government are obligated to revisit their Illinois Solid Waste Management Plans every five years and, if necessary, submit plans with significant updates to the Illinois EPA. Through this funding opportunity, Illinois EPA intends to provide interested counties (and other units of local government required to develop a county solid waste management plan) with financial assistance to help prepare the next plan update.

Eligible projects include, but are not limited to, conducting a local solid waste and materials management needs assessment, surveying local solid waste and materials management stakeholders to determine programmatic expansion viability, internally authoring solid waste management plan updates, or procuring consulting services to prepare solid waste management plan updates. Each county or unit of local government is eligible for up to \$10,000 in funding. All required forms and information are here.

Applications for the County Solid Waste Planning Grants will be accepted through 5pm on March 3, 2023.

Social Equity Cannabis License Lottery: The Illinois Department of Financial and Professional Regulation announced two key updates for the upcoming Social Equity Criteria Lottery for the next round of adult use cannabis dispensary licenses in Illinois. First, the application deadline has been extended through Friday, March 3, 2023. This replaces the original February 14 deadline and will give prospective applicants a total of five weeks to submit their applications. The application window will still open for applicants on January 30 through IDFPR's online portal.

With respect to the second key update, IDFPR is providing an <u>interactive map</u> on its website for all prospective applicants. This map allows individuals to check if an individual address is within a census tract that qualifies for one of the required <u>social equity criteria</u>. The Department encourages all individuals to utilize this map as they prepare their applications.

Additional resources for the Social Equity Criteria Lottery (including a step-by-step breakdown of the lottery and licensing process, a mock application, and a guide for acceptable documents to fulfill the social equity criteria) is located on IDFPR's Adult Use Cannabis webpage under the "Information for Social Equity Criteria Lottery" section.

Cannabis Transporter Licenses Awarded: The Illinois Department of Agriculture issued 33 transporter licenses, successfully closing the 2022 application pool. These licenses are in addition to the 88 Craft Grow licenses and 54 Infuser licenses already issued to date, bringing to 222 the total number of Illinois licensed transporters. The current list of licensees is available on the department's website.

Open Doors Homeownership Program: The Illinois Housing Development Authority reopened the "Opening Doors" program which is designed to help working-class families and underrepresented communities of color throughout the state of Illinois with \$6,000 in forgivable assistance for down payment and/or closing costs. The latest round will offer \$8 million and serve approximately 1,300 homebuyers.

- Michelle Dawn Carrera will serve as a member on the Illinois State Police Merit Board
- Dr. Maureen C. Mosley Banks will serve as a member on the Illinois Community College Board
- Aarti Kotak will serve as a member on the Illinois Sports Facilities Authority
- Dr. Anna Grasselino will serve as a member on the Illinois State Board of Education
- Mario Farfan will serve as a member on the Enterprise Zone Board

OTHER NEWS:

Secretary of State: Secretary of State Alexi Giannoulias released his Transition Team's report which will serve as the blueprint for modernizing the office, transforming operations, and expanding services. Highlights from the report including:

- Improving driver services facilities
- Strengthening lobbyist registration guidelines, increasing transparency, expanding disclosure requirements, and modernizing the lobbyist registration database
- Library enhancements such as accessibility of e-books and online education resources
- Enhancing the securities divisions
- Increasing voter participation through the expansion of access, motor voter registration, and educating voters about voting locations and election dates
- Making technology advancements to enable the office to establish digital driver's license and digital identification cards, an electronic car title system, and a mobile app to conduct transactions
- Enhancing business support services
- Enhancing the organ and tissue donor program
- Reducing the office's environmental footprint and using SOS offices to education the public about environmental initiatives

Assault Weapons Ban: The Illinois State Rifle Association (ISRA), the Firearms Policy Coalition, Inc., the Second Amendment Foundation, two gun stores and a gun owner filed a federal lawsuit in the United States District Court for the Southern District of Illinois against Illinois Attorney General Kwame Raoul, the Director of the Illinois State Police Brendan Reilly, and numerous Illinois State's Attorneys challenging Illinois' assault weapons ban. SUBJECT: Better Bus Stops Campaign Review

Recommendation:

Approve moving forward with 73 planned Better Bus Stop Campaign improvements and 70 high confidence Better Bus Stop Campaign improvements. The remaining Better Bus Stop Campaign bus stops will be delayed until after the route study is completed.

Background:

At the November 2022 meeting of the Board of Trustees, the Board and staff discussed the Better Bus Stops Campaign and the next steps regarding the program given our upcoming route analysis, with the intent to bring a recommendation on which stops we will be pursuing next, along with a plan for community members, businesses, and riders alike to request a new stop or to request a stop be updated.

Discussion:

To briefly recap, to-date we have improved 180 of 461 stops and have invested a total of \$1.2 million into the program. Staff has reviewed the existing plan, as well as upcoming Connect Transit activities, to develop a program that will allow Connect to continue building accessible stops without investing unnecessarily on stops with no utilization.

This spring, as we work with our consultant for Microtransit and planning, our goal is to not spend additional dollars in areas with the chance that routing or long-term plans will be adjusted. Staff feels confident, however, that some corridors like those near densely residential or commercial areas, will be safe to invest funds into as service will exist in one form or another. With some grant funding remaining in the Better Bus Stops program, staff recommends beginning NEPA and other review processes on these 70 high confidence stops to ensure that secured funding is appropriately invested into the community.

In addition to the 70 high confidence stops, NEPA and design work has been completed on 73 stops throughout Bloomington and Normal. Staff recommends targeting these stops for completion this year as well, allowing for Connect to obligate all remaining federal grant funds.

Finally, after this batch of 143 stops, we can expect to have completed 323 of 461 total stops, or 70%. For the remaining 30% (138 stops), staff hopes to begin with the highest ridership stops first as consulting and decision making takes place, avoiding spending valuable resources on stops with little, or in some cases, zero, ridership. Staff also aims to have a stop and service request portal in place on the Connect Transit website by late spring with the hope of better community engagement.

Financial Impact:

No change in planned expenses.

Subject: Contract for Enterprise Transit Management Solution Software Conversion

Recommendation:

Authorize the General Manager to execute a contract with Avail Technologies for Enterprise Transit Management Solution (ETMS) software, hosting, and support.

Background:

Connect Transit began using the Fleet-Net Enterprise Resource Planning (ERP) software package in 2012. Since that time, we have used Fleet-Net as the primary software for most of our core functions including payroll, accounting, Maintenance operations, asset management, and much more.

The Fleet-Net product has not evolved much since its original installation other than minor improvements and bug fixes. In 2017 Avail Technologies acquired Fleet-Net with the goal of modernizing the software as a companion for it's existing CAD/AVL solutions. Since 2017, Avail Technologies has been doing extensive work to modernize the underlying database and software. The next phase of the modernization roadmap includes moving the Fleet-Net product from a traditional on-premises software solution to a cloud-hosted product. As such, Avail Technologies has outlined an End-of-Life announcement for the current on premises ERP product. In order to continue to modernize the software, it must become a cloud-hosted solution.

Discussion:

Connect Transit staff frequently seeks to modernize software solutions used in providing the services to our community. Like this one, many of these systems are not customer facing but are vital in operating the agency. As such, Connect Transit staff is recommending that we move forward with completing this transition to the cloud hosted ETMS solution.

There was no procurement action taken on this project and it will be considered a valid sole source project. This is simply a planned upgrade that was previously communicated with an existing vendor. Only the support and hosting for the software is being updated to a more secure and



reliable environment. In addition, the cost to replace the existing software in a new deployment with a new vendor is estimated to cost up to ten times the cost of this project.

To complete this project, Connect Transit staff will work with Avail Technologies to begin moving the existing ERP system to the cloud-hosting provider. Moving the product to the cloud will shift the burden for supporting software and hardware to experts that can resolve problems much more quickly. In addition, Avail Technologies ensures us that the data stored within the system is not only more secure, but it is also accessible by appropriate Connect Transit staff from anywhere they have an internet connection. Avail has also outlined a roadmap to continue to develop the software into the future by introducing new user interfaces and features.

Financial Impact:

The total cost for this project is \$153,537, this includes continued support for the current on premises solution until the ETMS conversion can take place, the conversion to the ETMS system, and ongoing support and hosting fees associated with the ETMS through the end of 2024. This project is funded as an operating expense.
