Monthly Federal Update for Connect Transit

Congressional Update

Following a raucous beginning to the first week of January with the prolonged election of Kevin McCarthy as Speaker of the House, there has been little action since. The Senate has focused on confirmation of the President's judicial nominees and filling vacancies in the Executive Branch, while the House has focused on the routine organization of its committees. The House recessed for a two week district work period and the Senate plans to take a one week break President's Day week with both Houses set to resume work February 27th.

Appropriations Process Gets a Late Start

Despite the approval by the new House Republican Majority of the continued use of Congressionally Directed Spending, (earmarks) in appropriations bills, House Republicans are negotiating new rules for earmarks for this year's Appropriations process. It has been reported that "the chamber's new majority plans to limit the types of projects that are eligible for guaranteed cash. For instance, they would prevent lawmakers from locking in funding for items like city parks and county museums — things that might brandish a member's name." This change is not expected to change transportation and transit requests; however, agreement on the new rules has delayed the entire process. With Congress on recess until February 27th it is likely the start of the annual process will be delayed until March. Connect is evaluating which projects will be submitted for these requests.

President Delivers State of the Union Address

President Biden delivered his State of the Union address February 7th with a full chamber and no COVID restrictions for the first time since becoming president. Below are some of the key themes from his speech, along with the rebuttal from Arkansas Governor, Sarah Huckabee Sanders.

Key Message Points:

- Everything in America is a possibility; time and again, Democrats and Republicans have come together. From passing the Infrastructure law to helping victims exposed to toxic burn pits, as well as protecting the freedom to marry the person you love—all made possible by working together.
- Inflation, while a global problem, is coming down, including food and gas inflation, while take-home pay is going up.
- "Jobs are coming back, pride is coming back."
- Democracy is an American issue, and one to be protected.

Speech Highlights:

- 3.4% unemployment rate, a 50-year low. Near record unemployment for Black and Hispanic workers, and a turnaround in creating new manufacturing jobs.
- A record 10 million Americans in 2022 applied for small business licenses.
- We now produce 10% of all chips, up from where we were during the pandemic; the bipartisan Chips legislation will keep us moving forward in this area.
- Emphasized the importance of rebuilding our infrastructure; we're now 13th in the world in infrastructure (used to be 1st), but "we're coming back." We've already funded 20,000 infrastructure projects and "we're just getting started."
- The freight route bridge (Brent Spence Bridge) across the Ohio River in Kentucky is being rebuilt, using \$1.6 billion in Federal infrastructure monies to fund it.
- Replacing poisonous lead pipes, especially those providing water to schools and homes is very important to the administration.

- Making sure every home has access to high-speed Internet (we're not there but working towards it).
- All infrastructure projects funded with federal money will be built with materials made in America, as a requirement.
- Stressed the importance of cutting shipping costs, and that the White House will continue to work on ways to do so.
- We need to protect the dignity of work, and the right to form a union.

Republican Rebuttal:

As is expected throughout the 118th Congress, Republicans will continue to investigate COVID spending, the withdrawal from Afghanistan, the origins of COVID, and implementation of recently passed legislation such as the bipartisan infrastructure law. Gov. Huckabee Sanders did not mention former President Trump by name during her speech, but the rhetorical and political legacy of Trump was obvious throughout. Oversight of bigtech is an area where both parties have a legislative appetite, but it remains to be seen whether they can come together on a regulatory framework.

House Transportation & Infrastructure Holds First Hearing

On February 1st The Committee on Transportation and Infrastructure held its first hearing of the 118th Congress on "The State of Transportation Infrastructure and Supply Chain Challenges."

Transportation and Infrastructure Committee Chairman Sam Graves (R-MO) announced the vice chairs for the Committee's six subcommittees.

- Coast Guard and Maritime Transportation: Rep. Mike Ezell (R-MS)
- Economic Development, Public Buildings, and Emergency Management: Rep. Lori Chavez-DeRemer (R-OR)
- Highways and Transit: Rep. John S. Duarte (R-CA)
- Railroads, Pipelines, and Hazardous Materials: Rep. Brandon Williams (R-NY)
- Water Resources and Environment: Rep. John James (R-MI)

Chairman Graves named Rep. Jeff Van Drew (R-NJ) as Vice Chairman of the full Transportation and Infrastructure Committee.

2023 Low/No and BBF NOFO

FTA announced on January 27th the funding opportunity for 2023 Low or No Emission and Bus and Bus Facilities programs. The application deadline is April 13th.

FTA's <u>Low or No Emission (Low-No) Program</u> helps transit agencies buy or lease U.S.-built zero-emission and low-emission transit buses along with charging equipment and supporting facilities. The Bipartisan Infrastructure Law provides \$5.5 billion over five years for the program – more than six times greater than the previous five years of funding. For Fiscal Year 2023, approximately \$1.22 billion will be available for grants under this program.

FTA's <u>Grants for Buses and Bus Facilities Program</u> supports transit agencies in buying and rehabilitating buses, vans, and related equipment and building bus facilities. The Bipartisan Infrastructure Law provides nearly \$2 billion over five years for the program. For Fiscal Year 2023, approximately \$469 million for grants will be available. Both programs support buses that reduce air pollution and help meet President Biden's goal of netzero emissions by 2050.

The Climate Pollution Reduction Grants (CPRG) program

EPA announced it will release a Notice of Funding Opportunity March 1 for the new CPRG program created by the Inflation Reduction Act. The program will provide grants to states, territories, tribes, air pollution control agencies, and local governments to develop and implement plans for reducing greenhouse gas emissions and other harmful air pollution. Section 60114 of the Inflation Reduction Act provides an investment of \$5 billion to support efforts by states, territories, municipalities, tribes, and groups thereof to develop and implement strong, local greenhouse gas reduction strategies. This two-staged grant program provides funding of \$250 million for noncompetitive planning grants, and \$4.6 billion for competitive implementation grants.

Mega Grant Awards Announced

President Biden and Transportation Secretary Pete Buttigieg announced that the Biden-Harris Administration has awarded nearly \$1.2 billion from the new **National Infrastructure Project Assistance (Mega)** discretionary grant program for nine projects across the country.

The Mega grant program, created by President Biden's infrastructure law, funds projects that are too large or complex for traditional funding programs. Eligible projects include highway, bridge, freight, port, passenger rail, and public transportation projects that are a part of one of the other project types.

The Mega program will invest a total of \$5 billion through 2026 to help rebuild the United States' infrastructure for the benefit of Americans now and for generations to come. For this application cycle specifically, the U.S. Department of Transportation received applications requesting approximately \$30 billion in funding, far exceeding the \$1 billion of funding available in 2022.

General Legislative Updates

GOVERNOR'S HIGHLIGHTS:

On Wednesday, Democratic Governor JB Pritzker delivered his fifth Budget and State of the State Address to a joint session of the Illinois General Assembly. This marks the first budget of the Governor's second term and the first time in two years that the Governor was able to present his speech in-person in the House chamber. The last two budgets were delivered in alternative formats due to COVID restrictions in 2021 and then a massive snowstorm which cancelled session in 2022.

The Governor's speech struck an optimistic tone, highlighting the fiscal accomplishments of his first term including eliminating the \$17 billion bill backlog, allocating \$2.3 billion into the Rainy Day Fund, and using fiscal restraint to position Illinois for six credit rating upgrades. The Governor also noted that Illinois is using budget surpluses to chip away at long-term liabilities including pension debt.

The proposed FY24 budget allocates \$118.9 billion All Funds spending, including \$49.642 billion General Revenue Funds -- down \$349 million over FY23. Surpluses are projected in both the current and upcoming fiscal year: \$303 million surplus for FY24 and \$1.368 billion for FY23.

The Governor insists the proposed budget is predicated on conservative revenue estimate, in light of predictions of a looming recession. The FY24 budget assumes \$49.944 billion in base General Funds revenue, which is a \$1.4 billion (2.8%) decrease from revised FY23 estimates. Individual income taxes are forecast to grow \$778 million (3.3%). Offsetting that projected increase are predicted declines: corporate income tax forecasts assume lower corporate profits, sales tax growth is projected to remain flat, transfers-in are expected to drop by \$1.279 billion, and federal revenues are expected to remain flat over last year.

Rainy Day Fund: The FY24 proposed budget continues to prioritize putting funds into the State's Budget Stabilization Fund (commonly referred to as the Rainy Day Fund). FY24 targets \$138 million for the Budget Stabilization Fund, while the FY23 budget is expected to receive \$1.174 billion from surpluses.

Pensions: The FY24 proposed budget fully funds the state's pension obligations while also setting aside \$200 million for the Pension Stabilization Fund.

Smart Start Illinois/Early Childhood Education: Pritzker is proposing a four-year Smart Start Illinois plan that will ultimately create 20,000 additional seats for 3- and 4-year-olds in preschool programs. The proposed FY24 budget allocates \$250 million for its first year, distributed as follows:

- \$75 million additional for the Early Childhood Block Grant at ISBE to create 5,000 preschool spots.
- \$130 million to begin funding Childcare Workforce Compensation Contracts to offer raises to childcare workers.
- \$40 million increase for early intervention programs to maintain services and offer provider wage increases.
- \$5 million to expand DHS' Home Visiting Program to reach families in need of support.

In addition to the Smart Start Illinois funding, Governor Pritzker is proposing additional early childhood education funding, including:

- \$100 million to improve early childhood provider buildings and facilities.
- \$70 million to cover increases in the Child Care Assistant Program.
- \$20 million for DHS to revamp the payment system to providers.

K – **12 Funding:** The FY24 budget includes an additional \$571 million for the Illinois State Board of Education. The Evidence-Based Funding Formula is increased by \$350 million. An additional \$86.4 million is allocated for transportation grants and special education grants. Another \$70 million is directed towards a new three-year pilot program to improve the teacher pipeline.

Higher Education: The FY24 proposed budget includes a \$219 million increase for higher education. MAP funding is increased by \$100 million. The Governor believes this boost -- combined with federally funded Pell grants -- is sufficient to allow attendance of college free of tuition and fees for nearly every community college student and 40 percent of public university students (whose household incomes are at or below median income levels).

Public Universities and community college operations will receive a 7% increase (\$100 million) in the Governor's proposed budget. Community college investments include: \$8.3 million for dual credit and one-credit workforce grant programs, \$11 million for development of advanced manufacturing, EV technology and data center workforce training programs, and \$750,000 to expand English language services.

Healthcare and Family Services: The FY 24 proposed budget allocates \$37.188 billion All Funds, including \$9.070 billion GRF to the Department of Healthcare and Family Services.

FY24 Medicaid liability is projected to total \$25.88 billion All Funds, with a total program enrollment of more than 3.7 million (up 1.2% over FY 23). The FY24 budget proposal allows for the end of the federal public health emergency; redeterminations will begin this Spring. The budget also reflects the Spring 2023 phase-out of the enhanced federal Medicaid match.

The proposed budget includes \$8 million for a "Ready to Renew" campaign to help Medicaid enrollees maintain their coverage or transition to other health insurance. The proposed budget includes funding to

raise the asset limit for senior enrollees or those with a disability. Also included is \$100 million for increases in reimbursement rates for providers.

The "Healthcare Works Illinois" program will receive \$450 million over multiple years, aimed at preserving and expanding the healthcare workforce. Hospitals, clinics, behavioral health providers, home health workers, and others will be eligible for the funding -- monies can be used for such areas as expanding entry pipeline for healthcare workers, continuing education trainings for providers, and other vital investments in staff retention and recruitment. Other noteworthy investments include a \$3 million allocation towards the Healthcare Workforce Loan Repayment and Scholarship program; a \$25 million rate increase for physicians to broaden access to critical healthcare services; \$25 million of continued funding for the Pipeline for the Advancement of Healthcare Workforce Program to train new nurses, medical assistants, lab techs, EMTs and others.

Homeless Prevention: The Governor is proposing a "Home Illinois" program, housed at the Department of Human Services, which will target the prevention of homelessness, provide crisis response, expand housing support and increase job opportunities for the homeless. An initial investment of \$350 million will include:

- \$26 million to provide homeless prevention services to 5,000 families.
- \$30 million to maintain court-based rental assistance.
- Over \$155 million to support unhoused populations seeking shelter and services.
- \$25 million in rapid re-housing services to 1,000 households.
- \$40 million for Permanent Supportive Housing.
- \$12.5 million to create 500 new scattered site permanent supportive housing units.
- \$37 million for Emergency Shelter Capital to create over 460 non-congregate shelter units.
- \$30 million to provide street outreach, medical respite, and other shelter diversion supports.
- \$5 million for a new workforce development pilot program to help homeless adults attain and retain employment.

DHS: The FY 24 proposed budget includes \$2 billion (\$200 million increase) for services for people with developmental disabilities in support of the *Ligas* consent decree. Also included is a \$50 million increase for TANF. The proposed budget includes \$10 million to fund the Children's Behavioral Health Transformation for Comprehensive Community Based Youth Services and \$1.5 million for a care intake portal. An additional \$30.8 million is in the proposed budget to address growing caseloads with the Home Services Program and \$10 million is budgeted to support the Paid Leave for All Workers Act. Another \$32.5 million is targeted to increase forensic inpatient and outpatient services and support the *Williams* and *Colbert* consent decrees.

DCFS: The FY24 budget increases the DCFS budget by \$54.6 million. The proposed budget:

- Continues rate reform for private sector providers in order to address staffing shortages of social service workers at DCFS partner agencies.
- Allocates \$10 million towards the Lone Worker Safety Devices program for emergency communication and supportive partnership contracts with local sheriff offices, enhancing safety protocols and the acquisition and training in the use of items like defensive sprays.

- Increases by \$41 million increase the main rollout of the Comprehensive Child Welfare Information System.
- Earmarks \$30 million for Level of Care Support Services capital grants to provider, helping to increase capacity for youth placement in the most clinically appropriate settings.

IDPH: The proposed FY24 budget includes \$45 million to support IT replacement for the Illinois' National Electronic Disease Surveillance Systems and Long-Term Care systems. Another \$8.5 million is targeted to respond to unexpected public health threats and emergencies; \$18 million to support reproductive health initiatives (see below); \$7 million to improve public health communications in order to reduce health disparities; and \$2 million for mental health training for front-line workers in the pediatric field.

Reproductive Health: Reproductive health continues to be a priority for the Pritzker administration. The Governor calls for creating a new Reproductive Health Public Navigation Hotline to enable patients to call ahead for a risk assessment and find services such as transportation, lodging, and insurance coverage options. The proposed budget also allocates \$5 million toward learning collaboratives for worker training to address the shortage of reproductive healthcare workers.

Other Funding Increase:

- \$27.4 million for the Community Care Program to serve an estimated 68,000 seniors
- \$8 million for the Home-Delivered-Meals Program
- \$17.5 million for two Illinois State Police Cadet Classes
- \$5.2 million for motor vehicle and body camera cloud storage
- \$30 million for camera grants to local law enforcement
- \$10 million for resources to local law enforcement agencies for recruitment of new officers and retention plans
- \$20 million for the new Illinois Grocery Initiative to address food insecurity
- \$40 million to support the Social Equity Cannabis Loan program
- \$20 million to support Illinois entities seeking competitive federal awards that align with the state's economic development plan
- \$20 million for Fast-Track Workforce program to help employers do employee screening, recruitment, and job training
- Carries forward the \$400 million set aside in FY23 for efforts that support job creation and business development through the Invest in Illinois Act closing fund
- \$10 million for a multi-year initiative to develop and implement a one-stop business portal to assist individuals wishing to create new businesses or relocate a business to Illinois
- \$10 million to start a Clean Energy Career and Technical Education pilot program, helping high schools to develop technical education programming on electric vehicle manufacturing.
- Maintains OSLAD grants for local government for community park projects at its current level of \$56 million
- LGDF is held flat to FY 23
- \$20.5 million for addition Electric Vehicle rebates
- \$10 million in capital funding for new Lead Service Line Replacement Inventory grants

Capital Budget: The proposed FY 24 budget includes \$46.5 billion in total capital appropriations (\$4.97 billion in new capital appropriations), including: \$3.3 billion for the Department of Transportation; \$1.1 billion for the Environmental Protection Agency; \$244.6 million for the Department of Natural Resource; \$151.5 million for the Capital Development Board; \$97.0 million for the Department of Commerce & Economic Opportunity; and \$85.5 million for other State agencies. Highlights include \$100 million in new funding for early childhood education facilities, \$20 million for new Rebuild Illinois Downtowns and Main Streets awards for community revitalization and \$25 million to bolster the Illinois Works Pre-Apprenticeship Program.

Key budget documents are available: <u>Budget in Brief</u>, the <u>Operating Budget</u>, and the <u>Capital Budget</u>.

New Laws: The Governor continues to sign legislation from the January lame-duck session. The latest bill signings include:

- <u>HB 45</u> Amends the Election Code surrounding Judicial Subcircuits.
- <u>HB 268</u> Creates the Tourism Preservation and Sustainability District Act.
- HB 1064 Abolishes life without parole for people under 21 years of age.
- <u>HB 1563</u> Amends the CMS Services Law of the Civil Administration Code to remove the preference for location of jobs in Sangamon County.
- <u>HB 1688</u> Allows cars, vans, and other first division vehicles to operate as school buses under a Secretary of State permit.
- <u>HB 1859</u> Amends the Cook County Forest Preserve Article of the Illinois Pension Code.
- <u>HB 2369</u> Amends the Department of Veterans' Affairs Act regarding Veterans Assistance Commissions.
- <u>HB 2542</u> Allows qualifying individuals who previously had a felony conviction to legally change their name.
- HB 2870 Amends the Regional Water Commissions Division of the Illinois Municipal Code.
- HB 3878 Makes changes to the Rental Housing Support Program.
- HB 4228 Amends the Decennial Committees on Local Government Efficiency Act.
- <u>HB 4245</u> Amends the Illinois Plumbing License Law to ensure that lawn irrigation and lawn sprinkler system installation is well regulated in perpetuity past the current sunset date of January 1, 2024.

<u>HB 5107</u> Allows school principals to be eligible for collective bargaining exclusively in Chicago.

<u>HB 5285</u> Creates transparency in the process of hiring school principals in an effort to ensure schools have the necessary information to hire the most qualified candidate exclusively in Chicago.

<u>HB 5542</u> Makes various changes regarding the operations of the Illinois Joint Forces Foundation Fund.

Gubernatorial Appointments: The Governor appointed the following:

- Efi James will serve as an Arbitrator for the Illinois Workers' Compensation Commission.
- Harold Mays will continue to serve as Director of the Illinois Department of the Lottery.

103rd ILLINOIS GENERAL ASSEMBLY:

The Illinois General Assembly was in Session Tuesday through Thursday of this week. Both chambers return to session on Tuesday, February 21. Friday, February 17 is the deadline to introduce substantive House Bills.

The focus this week was on the Governor's combined Budget and State of the State Address. The Legislature will now begin considering legislation at the committee level and reviewing agency budget requests.

The House Energy and Environment Committee will hold a hearing on February 21 at 3:00 pm in Room 114 of the Capitol to discuss the IPA and ICC.

The House Gaming Committee will hold a subject matter hearing on February 22 at 4:00 pm in Room 114 of the Capitol Building to discuss the Gaming Board, the Racing Board, and the Lottery.

House Democratic Budget Working Group: Speaker Pro Tempore Jehan Gordon-Booth, Majority Leader Robyn Gabel, Assistant Majority Leader Kelly Burke, Deputy Majority Leader Lisa Hernandez, and Representatives Will Guzzardi and Mark Walker will lead the House Democratic caucus budget negotiations. Representative Gordon-Booth said she wants to work toward a "budget that is both fiscally and socially responsible."

New House GOP Working Groups: House Republican Leader Tony McCombie created five working groups to focus in key areas:

- Sustaining & Protecting At-Risk Kids: to protect children in the state's care from abuse and neglect.
- Supporting Women and Families: to make Illinois a place where families can move and grow for generations.

- Reigniting Illinois' Strong Economy: to improve Illinois' business climate, while still protecting workers and using strengths geography, workforce, and resources to bring job creators and opportunity home.
- Literacy Improves Future Endeavors: to address learning loss, improve reading literacy, and restore Illinois students to competitiveness.
- Improving Public Safety: to make neighborhoods safe again, protect law-abiding citizens, and respect law enforcement.

Subject: Contract for Microtransit Service Planning and Operations Software

Recommendation:

Authorize the General Manager to execute a contract with Via Mobility to provide microtransit planning services and operating software for a term of five years, with two optional contracts for two years each.

Background:

Connect Transit is striving to increase access to public transit services within the Connect Transit service area. Implementing an on-demand/demand responsive public transportation service (microtransit) will support this goal. The objective of the microtransit service will be to provide transportation options to the many areas of the community that do not currently have access to it, with the ability to connect to our existing network of services.

Discussion:

On November 16, 2022, we released a Request for Proposal (RFP) seeking proposals for planning services and operating software for microtransit services. The RFP detailed our goals for the planning phase of this project, including the evaluation of our current fixed route system and how adding microtransit zones can supplement our existing services. The primary goals detailed for the software component of this project included a reservation system that provides a single mobile app allowing customers to book trips on the microtransit service, as well as providing an integration for real-time fixed route bus information and payment processing.

We received six proposals in response to this RFP. Our evaluation team of four staff members conducted a two-phased evaluation of the proposals. Phase I evaluated various elements of the proposals submitted. The team reviewed each proposer's approach to the technical and functional requirements of the planning phase, proposed software and support, references and related experience, and finally, the cost proposal. After evaluators completed scoring the elements of Phase I, the field of proposers was narrowed to the top three, who moved on to Phase II.

Phase II of the evaluation process engaged the proposers in an on-site demonstration of the proposed solution. Each proposer was asked to provide a brief presentation of their solution which was followed by a real world demonstration of the software solution in our community. Our staff ventured out into the community and staged five trips so they could evaluate the user experience of the mobile application while another staff member followed the instructions provided in the mobile driver app to provide service to those riders.

Below is a summary of the total evaluation scores from the top three proposers for this project:

Via Mobility achieved the highest overall score for both phases of the evaluation of this project. Our staff is familiar with Via Mobility due to our long-time relationship with Remix, a scheduling and planning software product provided by Via Mobility.

Via Mobility will utilize their dedicated in-house consulting team, Via Strategies, to evaluate the existing fixed route network performance and prepare a service plan. This service plan will include recommendations for improvement, as well as determine how on-demand microtransit can best integrate with the system to supplement current services.

In addition, Via Mobility will deliver their Software-as-a-Service (SaaS) solution to allow us to operate the microtransit service. This SaaS solution will provide a white-labeled rider app and web portal, web-based administrative console, driver app and a comprehensive reporting suite. The SaaS platform also provides routing and ride matching algorithms integration with third-party application programming interface (API) that will deliver a single unified platform. This platform will include multimodal and intermodal trip planning that allows riders to discover, plan and book trips on fixed route buses in the same app they use for microtransit services.

Via Mobility can utilize the same SaaS solution to assist us in providing paratransit services as well. While we currently have a provider that has been a valuable partner for paratransit software, we are also seeking Board approval of the option to add paratransit services to this contract upon expiration of the existing service contract if staff decides that providing a cohesive software and service is advantageous for our operations and our passengers.

Financial Impact:

The planning and software elements of this project will total \$75,500 and will be funded by \$60,400 FTA 5307 (annual federal appropriation) and \$15,100 local capital funding. Based on current projections for service hours for the upcoming microtransit service, the on-going software costs will

total approximately \$45,000 for the first year of this contract. Each year, the price will scale up (or down) based on the number of vehicles and hours that are operated for microtransit services. The software costs will be a new annual operating expense.

We also propose to include our current Remix software for the duration of the base contract. The cost for this software will be an average of \$35,630 annually, which is funded with operating funds. This represents a savings of \$7,311 annually from our stand-alone contract renewal rate.

The optional cost for the paratransit solution would include additional software implementation costs of \$45,000 for the first year of implementation and an average operating cost of \$82,675 per year thereafter based on the number of vehicle hours we currently operate. Similar to the microtransit services, software costs would be funded by FTA 5307 and local capital funds, and the operating costs would be included in our annual budget. Please note that we do not intend to exercise this option in 2024 but are including this in our contract to improve procurement efficiency when the current contract for paratransit software expires in October 2023.

Subject: Metropolitan Planning Organization (MPO) Agreement

Background:

During our 2022 Federal Transit Administration (FTA) Triennial Review, we received one finding. The finding concerned our lack of a signed Memorandum of Understanding (MOU) with the McLean County Regional Planning Commission (MCRPC) and missing required clauses in the 2018 agreement. Neither Connect Transit nor the MCRPC had a signed copy of our 2018 MOU. The new requirements were issued by the FTA in 2019 and the agreement was not changed at that time.

Discussion:

In August 2022, Jacob Smith, Connect Transit's Transportation Planner, provided the required clauses to the MCRPC, our local Metropolitan Planning Organization (MPO). Due to the number of participants in the MPO Agreement, including IDOT, Central Illinois Regional Airport (CIRA), the Town, the City and others, it has taken some time for the MCRPC to develop the document and gather necessary input.

Changes to the document are shown on the following page and include the required language concerning the sharing of data.

The MPO Agreement has been passed by the Technical Committee of the MCRPC and will be on the agenda at the February 24, 2023, Policy Committee for approval and signature.

The finalized document was due at the end of February however, I have asked for a one-month extension in the event the Policy Committee has any concerns.

DETAILED EXPLANATION FOR REVIEWER

The planning regulations require that the MPO, the state(s), and the public transportation operator(s) cooperatively determine their mutual responsibilities in carrying out the metropolitan transportation planning These responsibilities shall be clearly identified in written agreements among the MPO, the state(s), and the public transportation operator(s) serving the metropolitan planning area. Written agreements are required to address at least: 1) the recipient's responsibilities, 2) the development and sharing of information for financial plans, and 3) the development of the annual listing of obligated projects. If the recipient intends to rely on the MPO's public involvement process to meet Section 5307 public involvement requirements, FTA encourages it to state so in the agreement.
