#### **Federal Update for Connect Transit**

#### **Congressional Update**

The House passed a short-term government funding bill providing appropriations through December 16, 2022. President Biden signed the Continuing Resolution hours before a shutdown would've kicked in at midnight on September 30th. The lower chamber cleared the measure in a 230-201 vote, with only 10 Republicans supporting it. The funding bill also provides billions in additional Ukraine aid and disaster relief.

The temporary funding package buys time for congressional negotiations on a broader government spending deal that would increase agency budgets in the new fiscal year, which began October 1. But much hinges on the outcome of the elections, which will determine the makeup of Congress in 2023, including how both parties want to flex their leverage in spending talks.

The U.S. House of Representatives and the Senate are on recess until after the midterm elections on November 8. Once back in session, Congress will resume work on a number of pending items they need to complete before the end of the calendar year. With the continuing resolution to fund government operations and programs set to expire December 16, the FY23 spending package is at the top of the list. Senate Appropriations Chair and Ranking Member, Senators Leahy and Shelby are retiring at the end of the year and hope to finish their last spending bill on a strong note. Additionally, Congress will aim to wrap up the annual National Defense Authorization Act beginning with a procedural vote during the October recess where the relevant Committee Chairs, Senators Reed and Inhofe will return to DC to officially move onto the bill setting it up for consideration when members return in November. Senator Manchin's permitting proposal and additional hurricane disaster relief funding are also on the priority list. Lastly, relevant committee staff will use the October recess to finalize negotiations on the biennial Water Resources Development Act of 2022 to reauthorize U.S. Army Corps of Engineers' programs. It will be a busy November and December!

Over the Congressional recess, we will continue to monitor and share Federal agency activities along with news regarding implementation of the Bipartisan Infrastructure Law, Inflation Reduction Act, and CHIPS and Science Act, among others. For example:

- USDOT Marine Highway Project Awards
- USDOT Infrastructure Financing Measures
- DOE Publishes Clean Energy FOA
- IRS Fact Sheet and Requests for Comment on Climate and Energy Tax Incentives
- Following enactment of the CHIPS Act, <u>Intel</u>, <u>Micron</u>, and <u>Qualcomm and GlobalFoundries</u> have already made announcements to expand semiconductor manufacturing in the US.

#### **BIL Implementation**

On September 21, the U.S. Senate Committee on Environment and Public Works held a hearing on state and local perspectives of the Bipartisan Infrastructure Law (BIL). Witnesses included Nicole Majeski, Delaware Secretary of Transportation (home State of the Committee Chair); Jimmy Wriston, West Virginia Department of Transportation (home State of the Ranking Member); Regine Romero,

Mayor of Tucson; and Jim Tymon, head of AASHTO and former House T&I staffer. Tymon and Wriston highlighted concerns with the emphasis of funding in discretionary grants (available to state and locals) in BIL, which has resulted in a complex application process across numerous existing and new grant programs. Under the first year of BIL and FY22 appropriations, US DOT is responsible for administering \$28 billion in discretionary grants, compared to \$5 billion the previous year. However, BIL also significantly increased the formula funding levels for highway and transit programs.

States prefer the flexibility of formula programs (largely available to only state DOTs). Mayor Romero said he has not found the application process overly cumbersome but did mention the city has had to hire consultants to help navigate the grant programs. Secretary Majeski similarly noted that Delaware has turned to consultants for assistance while acknowledging the large amount of work required for grant applications.

#### **EV Charging Formula Grants Awarded**

All 50 states along with Washington, D.C. and Puerto Rico had their electric vehicle charging plans approved by DOT, allowing for the disbursement of \$1.5 billion to begin building out a nationwide EV charging network as envisioned by the infrastructure law. Ultimately, DOT approved every plan after earlier approving 35 plans, despite some states arguing that their drivers don't use EVs and that the money would be better spent elsewhere.

Secretary Buttigieg said the approval ensures "every part of the country — from the largest cities to the most rural communities — can be positioned to unlock the savings and benefits of electric vehicles." The \$1.5 billion in formula funding to states will be doled out in fiscal 2022 and fiscal 2023 for chargers intended to cover about 75,000 miles of highways. In total, the infrastructure law provides \$5 billion for the next five years to build and maintain a nationwide EV charging network.

#### **DOE State Energy Program**

The Department of Energy (DOE) has <u>announced</u> funding levels for the "State Energy Program" (SEP) to expand state clean energy programs. DOE is currently accepting applications from states and the list of eligible projects is *quite flexible*. This is a **formula grant program**, and each state's allocated amounts can be found here.

It may be worthwhile for you to connect with your state energy office to determine if any activities or buildings that you own could be eligible for some of this funding. Per DOE, SEP funding affords states broad flexibility to finance a range of activities and projects, such as: Installation of renewable energy systems and clean energy infrastructure; Innovative clean energy technology demonstration projects; Energy efficiency upgrades; Clean energy financing programs; Critical planning for clean energy and workforce development programs. The Bipartisan Infrastructure Law expanded the list of eligible projects and specifically included transportation efficiency and electrification.

Examples of previous projects that were funded through the program include:

- In Maryland, a partnership with IKEA to install a solar canopy and EV chargers in parking lots
- In Kentucky, the creation of a solar project siting tool
- In Wisconsin, improving energy security and resiliency for local and tribal governments
- In Arizona, completing critical energy efficiency upgrades to a city-owned building
- In Wyoming, distributing funds to local governments and businesses for efficiency upgrades

#### **EV Tax Credit**

U.S. lawmakers passed and Biden signed a provision in the Inflation Reduction Act that most legal experts see as an obvious violation of international trade rules. The new tax credit for U.S. buyers of qualifying electric vehicles made in North America has ignited the specter of a trade war as a domestic imperative of the Biden administration and Democrats collides with the complex realities of globalization. European Commission spokeswoman Miriam Garcia Ferrer said, "we think that it's discriminatory, that it's discriminating against foreign producers in relation to U.S. producers," calling the credits a "new, potential, trans-Atlantic trade barrier." "Of course this would mean that it would be incompatible with the WTO," she said.

#### **Buy America**

Three key House Transportation Committee Republicans are asking DOT's inspector general to investigate the Southeastern Pennsylvania Transportation Authority's compliance with FTA Buy America requirements with regard to a railcar procurement from the state-owned China Railway Rolling Stock MA Corporation. The \$138 million contract was awarded in 2017 and its initial delivery date of 2019 was pushed back to 2023.

#### Chairman Dfazio Letter

Chairman DeFazio, of the House Transportation and Infrastructure Committee sent a letter to FTA Administrator Fernandez expressing concerns over enforcement of the provisions prohibiting transit agencies from purchasing rolling stock from Chinese manufacturers. Specifically, the chairman is calling for FTA to implement enhanced oversight of State Owned Enterprises doing business with transit agencies, particularly those agencies that were exempt from the original legislation.

The letter suggests steps to be taken by FTA. "Such oversight standards could include recommendations to conduct additional audits beyond the currently mandated pre-award and post-delivery audits, as I understand has been done by one exempt transit agency in the past; practices for deeper vetting and verification of component and subcomponent cost and origin data; and other oversight enhancements as identified by FTA. While thorough Buy America compliance reviews are critical for all federally-funded procurements, they take on even greater significance for transit agencies purchasing rolling stock from entities that are intent on gaming the system and undermining legitimate competition. While transit agencies may be inclined to assume good faith by manufacturers in most of their procurements, this assumption should not be extended to predatory SOEs. FTA issuing a set of targeted oversight standards specifically for SOE procurements could help transit agencies ensure SOE compliance with Buy America until such time as Congress can fully prohibit transit agencies from making such procurements with federal funds."

#### **APTA**

APTA's TRAMSform conference was held in Seattle, WA October 9-11. Leaders representing all facets of the public transportation industry converged at APTA's TRANSform Conference this week in Seattle,

WA. Hosted by King County Metro, the event was APTA's largest ever annual conference, with more than 3,000 attendees and 135 exhibitors.

TRANSform began with the Opening General Session Mon., Oct. 10. APTA President and CEO Paul P. Skoutelas welcomed attendees. APTA Chair Dorval R. Carter Jr., president, Chicago Transit Authority; and Immediate Past Chair Jeffrey A. Nelson, CEO/managing director, Rock Island County Metropolitan Mass Transit District (Metrolink), Moline, IL, also gave remarks.

Terry White, general manager, King County Metro; Julie Timm, CEO, Sound Transit; King County Executive Dow Constantine; and Adiam Emery, director, transportation operations division, Seattle DOT, offered a welcome to the city. Veronique Hakim, senior vice president and national transit and rail market sector leader, HNTB Corporation, gave the sponsor remarks.

Francis "Buddy" Coleman, chief customer officer, Clever Devices Ltd, introduced keynote speaker Kal Penn, actor, writer, producer, and former associate director of the White House Office of Public Engagement.

The event included a General Session from FTA on Transit Workforce Solutions with FTA Administrator Nuria Fernandez, and an FRA Listening Session and Update with FRA Administrator Amit Bose and Deputy Administrator Jennifer Mitchell.

#### **APTA Legislative Committee Meeting**

The Legislative Committee heard from Paul Kincaid, Assistant Secretary for Legislative Affairs regarding current actions before Congress. He recapped the funding levels from the IIJA, particularly the large increases in funding for bus procurement and CIG. He emphasized the Buy America provisions as benefiting American workers and manufacturers. He brought attention to the flexibility available for transit agencies to use FHWA funds for some projects and encouraged everyone to visit the <a href="Flex Funding Website">Flex Funding Website</a>.

Kincaid also discussed the status of FY 2022 appropriations and the fact the current CR expires on December 16<sup>th</sup>. With passage of an omnibus appropriations bill in December the Department can move forward with FY 23 discretionary programs.

He announced the White House, DOT, EPA and Corps of Engineers would be holding a Webinar on Accelerating Infrastructure projects on October 13<sup>th</sup>. The summit will address resources made available by the \$1.2 trillion Infrastructure Investment and Jobs Act (*enacted November 2021*) as well as the \$739 billion Inflation Reduction Act (*enacted in August*) to rebuild roads, bridges, airports, rail and transit lines, and ports; expand access to high-speed internet; deploy clean energy; and strengthen the nation's resilience to climate change.

Kincaid mentioned the supply chain challenges and said that FTA is working with Mayor Landrieu and the White House to find solutions. He is particularly aware of the shortage of cutaways.

Former U.S. Senator Doug Jones spoke about the challenges APTA and the transit industry face in the upcoming congress, especially if one or both houses were to change partisan control. He reminded all agencies of the importance of holding their Members of Congress' feet to the fire and the need to invite their Member of Congress to see the infrastructure that is being put in place as a result of the IIJA.

Ward McCarragher – APTA Legislative Director

Ward provided an overview of the IIJA funding levels and the current status of the FY 23 Appropriations. Of the Covid Relief funding that was provided to transit agencies, 90% has been obligated and 70% outlayed. The FY 23 Appropriations bills differ in the amount of funding for the CIG program. The Senate is recommending \$4.11 Billion while the House has passed \$4.61 for CIG. These amounts will be reconciled in the final bill to be considered in December. He pointed out that there is a sizeable number of Republican Members of the House that oppose passage of any FY 23 Appropriations bill until next year when they hope to be in the majority.

The FTA and FRA have released notices of funding availability totaling \$5.3 billion so far, and they expect to release an additional \$7.6 billion. The remaining NOFO's are the Rail Vehicle Replacement and the Federal State Partnerships for Inter-City Passenger Rail programs.

The IRA contained extensions of the Clean Vehicle and Fuel Tax Credits as well as new climate and equity investments. The Commercial Clean Vehicle Tax Credit will apply to transit vehicles but APTA is awaiting Department of Treasury rules and guidance on implementation.

Ward also discussed the challenges facing the industry implementing the IIJA programs, including financial capacity, supply chain, inflation and workforce. The good news is that transit ridership has returned to 70% of pre-pandemic levels.

#### **Summary**

Over the past month, we have continued discussions with the Illinois Municipal League and Illinois Association of School Boards regarding potential strategies to address concerns with the Statement of Economic Interest form disclosures. We are currently gauging their interest in a grassroots campaign to address this issue. Additionally, we have continued our outreach to Rivian based on our previous discussions regarding the transfer center and are awaiting responses from their team.

Looking ahead to Veto Session, we expect to see the following issues at the forefront of discussions: reproductive rights legislation to protect providers performing abortions on out-of-state residents; amendments to the SAFE-T Act to clarify portions of the law and address controversial matters; potential changes to the Chicago elected school board legislation. We are also continuing to monitor for election or Lame Duck actions which could impact Connect Transit.

Creates the Electric Vehicle Charging Act, which may be referred to as the Beneficial Electrification Act. Sets forth requirements for parking spaces that are electrical vehicle ready applicable to new or renovated residential or nonresidential buildings. Sets forth provisions concerning electric vehicle charging station policies for unit owners and renters. Amends the Electric Vehicle Act. Creates the Electric Vehicle Access for All Program to maximize opportunities for carbon-free transportation across the State, particularly targeting environmental justice and low-income communities and to provide grants to pilot programs with the purpose of bridging public transportation gaps between residences and employment locations. Sets forth provisions concerning administrative review and authorized expenditure of State-controlled funds to accelerate electric vehicle adoption. Amends the Public Utilities Act. Provides that no later than May 31, 2022, electric utilities serving greater than 500,000 customers in the State shall file a Beneficial Electrification Plan with the Illinois Commerce Commission. Provides for review of the plans by the Commission and establishes a system for utilities to consider specified businesses, nonprofit organizations, or worker-owned cooperatives when awarding bids. Effective immediately.

#### House Floor Amendment No. 1

Replaces everything after the enacting clause. Creates the Electric Vehicle Charging Act. Provides that the Act applies to new single-family homes and newly constructed or renovated multi-unit residential buildings that have parking spaces and are constructed or renovated after the effective date of the Act. Defines terms. Provides that a new single-family residence or a small multi-family residence shall have at least one electric vehicle capable parking space for each residential unit that has dedicated parking, unless any subsequently adopted building code requires additional electric vehicle capable parking spaces or installed EVSE. Includes electric vehicle parking space requirements for a new, large multi-family residential building or a large multi-family residential building being renovated by a developer converting the property to an association. Includes electric vehicle parking space requirements for affordable housing and for an existing multi-unit residential building subject to an association that undertakes renovation. Includes electric vehicle charging station policies for unit owners and for renters.

#### House Floor Amendment No. 2

Removes language providing that "electric vehicle" does not mean electric motorcycles. Provides that "electric vehicle" does not include electric mopeds or electric off-highway vehicles.

#### House Floor Amendment No. 3

Provides that a new single-family residence or small multi-family residence that qualifies as an affordable housing development shall have one EV-capable parking space for each code-required parking space if the owner is issued a building permit 24 months after the effective date of the Act. Makes a conforming change.

Provides that it is unlawful for any public or private employer, entity, agency, institution, official, or person to deny admission because of, to place any reference in its application form concerning, to orally question about, to impose any burdens in terms or conditions of employment on, or to otherwise discriminate against, any applicant, in terms of employment, admission to or participation in any programs for which the applicant is eligible, or to discriminate in relation thereto, in any other manner, on account of the applicant's refusal to obtain, receive, or accept a COVID-19 vaccination that is against the applicant's beliefs. Provides that it is unlawful for any public official, guardian, agency, institution, or entity to deny any form of aid, assistance, or benefits, or to condition the reception in any way of any form of aid, assistance, or benefits, or in any other manner to coerce, disqualify, or discriminate against any person, otherwise entitled to such aid, assistance, or benefits, because that person refuses to obtain, receive, or accept a COVID-19 vaccination contrary to the person's belief. Allows any person injured by any public or private person, association, agency, entity, or corporation by reason of any action prohibited by the Act to bring an action. Provides that a person who brings an action shall recover threefold the actual damages, the costs of the action, and reasonable attorney's fees, but in no case shall recovery for each violation be less than \$2,500 plus costs of the action and reasonable attorney's fees. Makes other changes. Effective immediately.

#### **SB 3007**

Amends the Illinois Vehicle Code. Provides that the Secretary of State is authorized to suspend or revoke the driving privileges of any person without a preliminary hearing upon a showing of the person's records or other sufficient evidence that the person has committed an out-of-State offense similar to the Illinois prohibition on the unlawful use of a license, has possessed cannabis while under 21 years of age, or has provided false information about his or her age to a cannabis establishment.

Provides that driver rehabilitation specialists or programs are permitted to give driving instruction without being issued a license, except when the client of the specialist or program has never held a driver's license. Changes the implementation date concerning changes to the Secretary of State's requirements regarding the posting of certain information to the Commercial Driver's License Information System from June 22, 2021 to June 23, 2025. Provides that an individual shall be disqualified from operating a commercial motor vehicle for life if that individual uses a commercial motor vehicle in the commission of a felony involving an act or practice of severe forms of human trafficking. Amends the Probate Act of 1975. Provides requirements concerning probate court notifications to the Secretary of State in limited and plenary guardianship cases.

#### Senate Floor Amendment No. 1

Removes language providing that: if the court makes a finding that the respondent should not hold a driver's license, the clerk of the court shall provide a copy of the written order of limited guardianship to the Secretary of State; and if the court provides the guardian with the power to determine if the respondent may hold a driver's license, upon the guardian making a determination that the respondent should not hold a driver's license, the guardian shall notify the Secretary of State. Provides instead that when a court adjudges a respondent to be a person with a disability and appoints a plenary guardian for that person or enters an order finding that the respondent should not operate a motor vehicle, the court shall direct the circuit court clerk to notify the Secretary of State's Driver Services Department, in a form and manner prescribed by the Secretary of State, and shall forward a copy of the court order to the Secretary of State's Driver Services Department no later than 7 days after the entry of the order.

Provides that the Environmental Protection Agency is authorized to approve the use of examinations conducted by third parties. Provides that the Agency shall maintain on its website information regarding the examinations. Provides that at the time of certificate renewal, the applicant shall certify the completion of 30 hours of continuing education covering the operation of landfills during the preceding 3 years. Provides that the fee for the issuance or renewal of a Solid Waste Site Operator Certificate shall be \$1,000. Provides that if the fee for renewal is not paid within the grace period, the fee for renewal shall be increased by \$100 (rather than \$50). Makes other changes.

#### Senate Floor Amendment No. 3

Replaces everything after the enacting clause with the provisions of the introduced bill and makes the following changes. Provides that a landfill site that accepts non-hazardous solid waste shall have a Solid Waste Site Operator Certification (rather than a Class A or a Class B Solid Waste Site Operator Certification). Provides that a landfill site which accepts special waste shall have a Solid Waste Site Operator certified by the Environmental Protection Agency. Provides that solid waste site operators shall be certified based on level of competency determined by examination and in accordance with educational and experience level as follows: (1) graduation from high school or equivalent and not less than 2 years (rather than 6 months) of acceptable study, training, and responsible experience in sanitary landfill operation or management, or not less than 7 (rather than 3) years of acceptable study training and responsible experience in operation or management of earth moving equipment; or (2) grammar school completion or equivalent and not less than 15 (rather than 5) years of acceptable study, training, and responsible experience in sanitary landfill operation or management. Provides that at the time of certificate renewal the applicant shall certify the completion of 15 (rather than 30) hours of continuing education covering the operation of landfills during the preceding 3 years. Provides that continuing education used to satisfy continuing education requirements must be approved by the Agency and must cover the design, operation, and maintenance of sanitary landfills, and for certificates that include a special waste endorsement, continuing education must cover the operation of landfills relative to the acceptance and disposal of special wastes. Provides that the fee for a Solid Waste Site Operator Certificate shall be \$400 (rather than \$1,000) and provides that the fee for an issuance or renewal for special waste endorsements shall be \$100.

#### House Committee Amendment No. 1

Replaces everything after the enacting clause with the provisions of the engrossed bill, and makes the following changes: Amends the Illinois Oil and Gas Act. Defines "temporary abandonment status". Provides that before engaging in the business of removing liquid oil field waste from an on-site collection point, the person shall apply for a permit with a fee of \$150 (instead of \$100). Provides that each application to transport oil field waste shall be accompanied by a biennial permit fee of \$150 (instead of \$100) for each vehicle sought to be licensed. Provides the requirements for application for temporary abandonment status. Provides the requirements for a permittee to conduct a fluid level test upon the fluid in the well bore. Provides the fees that the Department of Natural Resources shall assess for each well in temporary abandonment status. Provides that each application for a permit to drill, deepen, convert, or amend shall be accompanied by a fee of \$400 (rather than a fee not to exceed \$300). Provides that the fee for an application for a permit to oil lease road shall be \$150. Provides that the fees per well to be paid by the new owner for each transfer of well ownership shall be \$75 for the first 100 wells and \$50 for each subsequent well in excess of 100. Provides that the Department shall assess and collect annual well fees from each permittee in the amount of \$100 (instead of \$75) per well for the first 100 wells and a \$75 fee (instead of \$50) for each well in excess of 100 for which a permit is required under the Act.

#### House Floor Amendment No. 2

Replaces everything after the enacting clause with the provisions of the engrossed bill, and makes the following changes: Amends the Illinois Oil and Gas Act. Defines "temporary abandonment status". Provides that before engaging in the business of removing liquid oil field waste from an on-site collection point, the person shall apply for a permit with a fee of \$150 (instead of \$100). Provides that

each application to transport oil field waste shall be accompanied by a biennial permit fee of \$150 (instead of \$100) for each vehicle sought to be licensed. Provides that the Department of Natural Resources shall assess and collect annual fees of \$100 per well for each well in temporary abandonment status. Provides that each application for a permit to drill, deepen, convert, or amend shall be accompanied by a fee of \$400 (rather than a fee not to exceed \$300). #### **General Legislative Updates**

#### **GOVERNOR'S HIGHLIGHTS:**

**COVID-19 Update:** Governor Pritzker issued Executive Order 2022-21 which reissues previous Executive Orders related to the COVID-19 pandemic through November 14, 2022. The updated executive order removes the weekly testing requirements for unvaccinated healthcare and long-term care workers. Face coverings are no longer required in all healthcare facilities but are still recommended in areas of high community transmission and the state will no longer mandate vaccines for long-term care and healthcare employees. Although the vaccine mandate has been removed on the state level, a federal rule from the Centers for Medicare and Medicaid Services requiring vaccination for workers at Medicare/Medicaid-certified facilities remains in effect. The amended executive order does not impact vaccination and testing requirements for state employees at state-owned congregate facilities.

**PACE Program**: The Illinois Finance Authority is launching a statewide PACE (Property Assessed Clean Energy) program designed to spur investment in electric vehicle charging stations, energy efficiency, and water conservation, and to stimulate the growth of renewable energy and resilient building design throughout Illinois. The Illinois Finance Authority PACE program is designed to reduce costs, improve service delivery, and create uniformity in Illinois' Commercial Property Assessed Clean Energy (C-PACE) financing market.

Under Illinois law, counties, cities, villages, and incorporated towns may create PACE areas at the request of for-profit and non-profit owners of commercial, industrial, and multi-family (of 5 or more units) properties. C-PACE financing can be used by owners and developers of commercial properties to finance or refinance eligible clean energy improvements in connection with the renovation of existing buildings and new construction, in each case up to 25% of the value of the property.

**Systemic Health Disparities:** The Illinois Department of Public Health is awarding up to \$3.7 million to 18 different organizations across Illinois to address systemic health disparities that have been highlighted by the COVID-19 pandemic. The ARISE (Activating Relationships In Illinois for Systemic Equity) program is a federally funded joint initiative of IDPH's Center for Minority Health Services and The Center for Rural Health, in collaboration with Well-being and Equity (WE) in the World.

The community coalitions will address inequities in mental, physical, and social well-being by connecting people to vaccinations, food, and other well-being needs. They will also address underlying community needs such as humane housing, reliable transportation, and the root causes of these inequities, including racism and poverty.

**Lead Service Line Replacement Grants:** The Illinois Environmental Protection Agency is offering a new funding opportunity to assist communities in meeting the requirements outlined in the Lead Service Line Replacement and Notification Act. The Lead Service Line Inventory (LSLI) Grant Program offers grants to local government units ranging from \$20,000 - \$50,000 to fund the creation of a complete lead service line inventory.

Applicants may request supplemental funding in the form of a low-interest loan through the Illinois EPA's Public Water Supply Loan Program.

All applicants must pre-qualify through the <u>Grant Accountability and Transparency Act Grantee Portal</u>. The LSLI NOFO, and all required forms and information, can be found <u>here</u>. Applications for the LSLI Grant Program will be accepted through Noon on December 2, 2022.

**IDOT's Building Blocks of Success:** The Illinois Department of Transportation is hosting free virtual workshops as part of its continuing Building Blocks of Success series for Disadvantaged Business Enterprise firms interested in strengthening their skills, growing their business and bidding on state projects. #### **ELECTION UPDATE:**

On Friday, a federal judge issued a preliminary injunction blocking provisions of two recently enacted laws that limit contributions in judicial races. The first provision prohibits judicial candidate committees from receiving any contributions from an out-of-state person. The second caps the amount that any independent expenditure committee established to support or oppose a judicial candidate can receive from any single source during an election cycle at \$500,000. The plaintiffs argued the provisions violate their free speech and sought to preliminarily enjoin the defendants from enforcing these two provisions during the upcoming November 8, 2022 election, a permanent injunction to the same effect for future election cycles, and a declaratory judgment that these two provisions are unconstitutional.

U.S. District Judge John Tharp Jr. ruled that the plaintiffs "have some likelihood of success" in proving their case that the laws are unconstitutional and should be overturned. He went on the say "the ban on out-of-state contributions will likely be more effective in preserving the status quo of the state's judiciary than in enhancing its appearance of integrity."

The ruling will impact contributions in two hotly contested Supreme Court races that could determine the balance of power on the state's high court.

#### Recommendation:

Authorize the General Manager to establish the "Star Pass" program that will allow zero-fare rides to all Veterans and active military personnel.

#### Background:

The program is a demonstration of Connect Transit's mission to provide access to opportunity, strengthen & enrich people's lives in our community, and is our way of saying, "Thank you for your service," to the men and women who have served to protect our freedom. The Star Pass provides qualified active U.S. military and U.S. military Veterans with free, unlimited rides on all Connect Transit provided transportation services.

#### Discussion:

The estimated financial impact is minimal.

#### Star Pass – Active-Duty Military and Military Veterans Pass Program

#### **Purpose:**

The Connect Transit "Star Pass" is zero-free pass for military Veterans and active-duty military personnel. The program is a demonstration of Connect Transit's mission to provide access to opportunity, strengthen & enrich people's lives in our community and is our way of saying "Thank you for your service" to the men and women who have served to protect our freedom. The Star Pass provides qualified active U.S. military and U.S. military Veterans with free, unlimited rides on all Connect Transit provided transportation services.

#### **Eligibility:**

- Active-duty Military Personnel
- Military Veterans (Including National Guard & Reserves)

#### **Confirmation/Verification Process:**

Eligible participants will need to complete a simple application. Applications must be submitted inperson at the Connect Transit offices located at 351, Wylie Dr., Normal, IL 61761 open Monday – Friday from 8:00am to 5:00pm. Offices are closed for major holidays.


Once you have completed the application, show one of the following to confirm eligibility:

- Active, Guard, Reserve, or Retired military ID card (not expired).
- State of Illinois ID card or Driver's License with "Veteran" status.
- State of Illinois ID card or Driver's License and a copy of your DD Form 214

Once approved, Connect Transit staff will take your photo and issue your card within minutes.

#### Pass:

Eligible participants will receive a Star Pass. The pass will be a swipe-card that will need to be swiped through the farebox upon boarding for each trip. Below is an example of what the Star Pass will look like.



#### **Alternative Distribution:**

For agencies or groups serving Veterans, please contact Connect Transit to schedule a time to come to your facility to provide passes. If space allows, we can set-up our intake and pass process in your facility. If not, we are happy to set up in our Community Bus on-site or near your operation.



Subject: Resuming Zero Fare System on Election Days

#### Background:

Prior to COVID-19, Connect Transit operated at zero fare on Election Days to increase opportunity for those in our community to express their right to vote. Research from 2021 says that the lack of personal transportation can correlate to a drop in voter turnout by 20%. While it can't be for certain that lack of transportation is the sole reason for not voting, we hope to lower the barrier that transportation causes.

#### Discussion:

Connect Transit believes that transportation should not be a barrier to access polling places. As a result, this year will resume our offer of zero fare rides across the entire system on November 8, 2022.

#### Financial Impact:

This will result in the loss of one day worth of fares.
